The HKSAR Basic Law Committee undertakes the tasks assigned by the Basic Law. The Committee makes suggestions to the SCNPC on interpreting or amending the Basic Law before proposals are placed on the NPC's agenda. On laws passed by the HKSAR Legislative Council and reported to the SCNPC, the latter must consult the Committee before it deems any law to be in contravention of the provisions of the Basic Law regarding affairs within the responsibility of the Central Authorities or with regard to the relations between the central authorities and the HKSAR. The SCNPC also must consult the Committee before it decides to add or delete from the list of national laws being applied in the HKSAR in Annex III, which stipulates the national laws that are applied in the HKSAR.
